Results of Meeting and Board Leadership Confirmations

Tartana Minerals Limited (ASX: TAT) (Tartana or the Company) provides the enclosed results of the Extraordinary General Meeting held today, 17 August 2026.

All resolutions were put to the meeting by way of a poll, and in summary:

- Resolution 1 to remove Stephen Bartrop as a director was carried
- Resolution 2 to remove Alistair Lewis as a director was withdrawn, given his resignation on Friday, 14 August
- Resolution 3 to remove Mat Hancock as a director was carried
- Resolution 4 to remove Michael Thirnbeck as a director was not carried
- Resolution 5 to remove Kiara Wang as a director was not carried
- Resolution 6 to remove Sonny Didugu as a director was not carried

As a result, the board now comprises Sonny Didugu as Executive Chairman, with Kiara Wang and Michael Thirnbeck as non-executive directors.

Commenting on today's result, Tartana's Executive Chairman Sonny Didugu said:

"Today marks the beginning of a new chapter for Tartana. Kiara, Michael, and I have won a decisive mandate to deliver immediate change within the Company. Our focus is now on accelerating our exploration programme across an expansive portfolio of exploration assets and improving governance and shareholder confidence.

"It is pleasing to see a strong vote in favour of the leadership changes I have put forward. The voting turnout was the highest seen in the Company's recent history, with over 50% of the Company voting by number of shares. I thank all shareholders for their participation and continued support of the Company.

"The hard work begins now, and I am looking forward to delivering and executing our new strategy for Tartana in the weeks to come."

Stephen Bartrop has advised that his engagement with the Company through his consulting entity, Troppo Resources Pty Ltd, ends today upon his removal as a director. Mat Hancock remains employed by the Company in accordance with the terms of his employment agreement. Boards of the Company's subsidiaries will also be amended today to reflect the current directors of the Company.

Following the meeting, Sonny Didugu has resigned as Company Secretary and has been replaced by Sean Meakin. For the purpose of ASX Listing Rule 12.6, both Sonny Didugu and Sean Meakin are persons responsible for communication with the ASX in relation to listing rule matters.

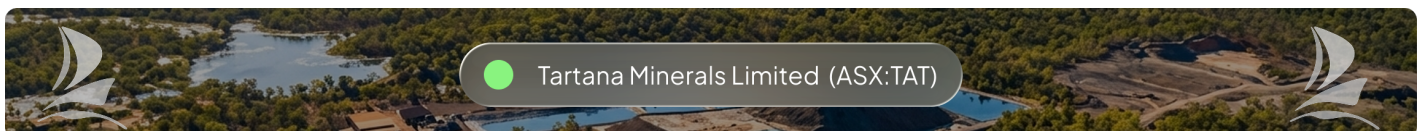
