Li-S Energy Limited (ASX: LIS) ("*Li-S Energy*", "*LIS*" or "*the Company*"), a leading Australian developer of ultra-lightweight lithium sulfur battery technology, has signed a Collaboration Agreement with EPE Trusted to Protect ("*EPE*"), one of Australia's most established and respected defence and national security companies.

Li-S Energy batteries can deliver almost twice the range, operating time and increase the payload carrying capacity of drones and unmanned systems. They also offer critical sovereign manufacturing and an allied materials supply chain. In the defence and security markets this drives substantial capability, performance and sovereign supply advantages for powering unmanned systems across air, sea and land domains.

The Agreement between EPE and LIS establishes a framework for joint evaluation, qualification and introduction of LIS's advanced cells across EPE's global network of customers and

technology partners. By engaging through a well-established partner, the Company gains structured access to a wide range of potential customer and partner opportunities that would otherwise need to be developed through many separate bilateral engagements.

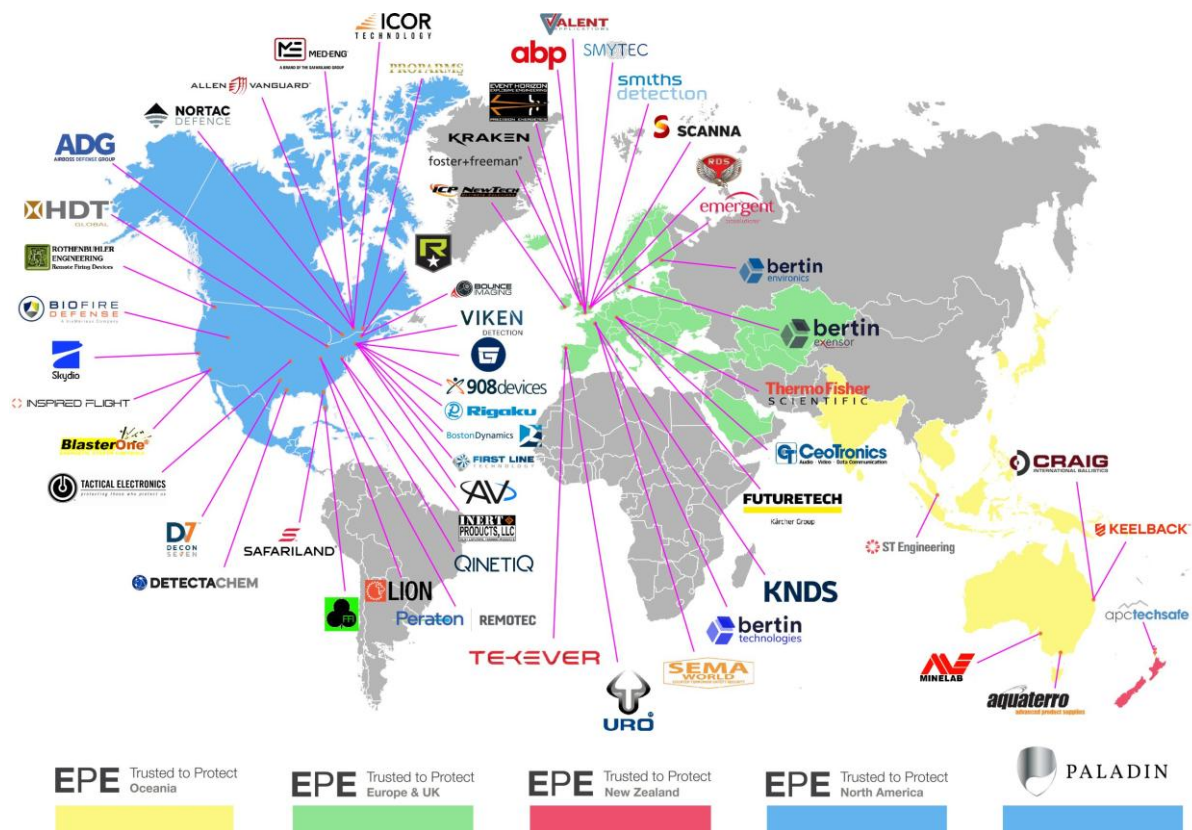

Under the Agreement, LIS and EPE will jointly evaluate, demonstrate and qualify LIS cells in key platforms, opening a route for potential battery supply into EPE partner platforms and end-customer systems.

Any commercial battery supply outcomes will depend on the results of evaluation and qualification programs and on the procurement decisions of EPE's customers and partners.
