Emyria Set to Launch First Sydney Clinic Following Key Operational Milestones

Clinic on-track for opening in Q3 2026, with fit-out finalised, medication and pharmaceutical partners secured, and first cohort of Authorised Prescribers and therapists trained

- **Sydney clinic fit-out complete** – four treatment rooms furnished and equipped ahead of the planned September 2026 opening.
- **Clinical team established ahead of launch** – ~20 Sydney-based therapists and 4 psychiatrists recruited and trained, providing the initial clinical capacity for the new site.
- **TGA endorsement of first 2 Sydney Authorised Prescribers** – supporting Emyria’s ability to commence treatments following opening.
- **Medication supply and key healthcare partnerships secured** – pharmacy and pharmaceutical arrangements in place, alongside a formal agreement with Matilda Nepean Private Hospital.
- **First patients already approved for treatment** – patients approved through the workers compensation pathway are expected to commence treatment shortly after the clinic opens.
- **Sydney launch expands Emyria into Australia’s largest population market** – establishing the Company’s first NSW presence and broadening access to evidence-based mental health treatments amid growing demand.

Emyria Limited (ASX: EMD) (“Emyria”, or the “Company”), a leader in delivering evidence-based intensive mental-health care, is pleased to announce that preparations for the opening of its first Sydney clinic are progressing as planned, with the clinic on track to commence operations in September 2026.

Significant operational milestones have now been completed ahead of opening. The Company has recruited and trained ~20 Sydney-based therapists and 4 psychiatrists, establishing the initial clinical team required to support the clinic’s launch.¹ Two Sydney psychiatrists have also obtained Authorised Prescriber status, while hospital, pharmacy, medication supply and other key healthcare arrangements have now been secured.

The Sydney clinic will establish Emyria’s first presence in New South Wales and represents an important step in the continued expansion of the Company’s national clinical network. With operations already established across Queensland, Victoria and Western Australia, the New South Wales clinic will extend Emyria’s treatment footprint into Australia’s most populous state, providing increased access to specialist mental health care in one of the country’s largest and most important healthcare markets.²

The clinic is now furnished and equipped, with four dedicated treatment rooms available to support patient care. Importantly, the first patients have already been approved for treatment through the workers compensation pathway and are expected to commence treatment shortly following the clinic's opening.

Planned clinic opening coinciding with growing demand for new evidence-based therapies

The expansion of Emyria's national clinic network comes at a time of increasing global interest, clinical validation and investment in psychedelic-assisted therapies and other emerging mental health treatments.

Growing policy support, pharmaceutical industry investment and broader institutional interest continue to reinforce the potential role of psychedelic-assisted therapies within the evolving mental health treatment landscape. Recent activity includes Eli Lilly's acquisition of AtaiBeckley for approximately \$3.8 billion³, Johnson & Johnson leading an \$85 million investment in Delix Therapeutics⁴, and policy initiatives in the United States aimed at accelerating access to emerging psychedelic-based treatments⁵.

Together, these developments reflect increasing global recognition of the need for new treatment options for patients who do not achieve adequate outcomes from conventional therapies. Emyria's expanding clinical network positions the Company to respond to this demand in Australia while continuing to build the clinical infrastructure, practitioner network and patient pathways required to support the delivery of evidence-based intensive mental health treatments.

Executive Chairman Greg Hutchinson commented:

"We are delighted with the progress being made towards the opening of our first Sydney clinic. With the fit-out complete, our initial clinical team trained, Authorised Prescribers in place and key medication and healthcare partnerships secured, the operational foundations required for launch are now substantially established."

"Sydney represents an important expansion of Emyria's national footprint and provides the Company with a presence in Australia's largest population market. Importantly, it will create a new pathway for patients across New South Wales seeking access to specialist and evidence-based mental health treatments."

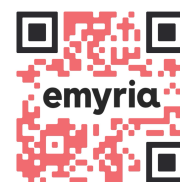
